Seabrook Nuclear Power Plant (Seabrook Station): Come learn about nuclear power generation in our backyard since 1990

Seabrook Station: Located approximately 40-miles north of Boston, MA and 10-miles south of Portsmouth, NH this facility has provided power from NH's Seacoast since August 1990 when commercial operation began. Seabrook Station is located on a 900-acre site (in the town's of Seabrook/Hampton/Hampton Falls, NH) and operates with a 1,100-person workforce during normal operations; which doubles during scheduled refueling outages. Seabrook Station is one of only a few nuclear power plants in the country that is ISO 14001 certified, recognizing the plant's leadership and excellence in environmental stewardship. The facilities annual power generation supplies enough for the needs of over 1-million homes.

Speaker: **David Barr** is Seabrook's Education Program Manager. He is a trained educator and holds a master's degree in educational media and design. He joined the Seabrook team in 1982, first working in the Training Department where he designed instructional materials for plant operations staff, and now is a member of the Communications staff. Based in Seabrook's public visitor center – The Science & Nature Center – David annually hosts thousands of high school, college, and adult visitors to see and learn about nuclear energy and its interaction with the environment on the seacoast. Some small groups are even able to take a walking tour inside the plant. David has worked closely with plant engineering and technical staff in a variety of roles during all 14 of Seabrook's refueling outages and he has photos and animated diagrams that will provide an up-close and personal look at the inner workings of the Seabrook plant.
